PRESIDENT'S CORNER

As this is already the Summer Issue and we are about half way through the year, I thought I would discuss a topic that I am often asked about. That subject is the various dues and payments associated with being a CHMM. It seems that we, as CHMMs, are asked for various amounts of money from various CHMM-related organizations. It can be difficult to understand who is asking for what. So, let me talk a little about dues and fees.

There are three separate entities that will ask you for dues (or fees) as a CHMM: 1) the Institute of Hazardous Materials Management (IHMM), 2) the National Academy of Certified Hazardous Materials Managers (ACHMM), and 3) the local Eastern Washington Chapter of the ACHMM (EWC/ACHMM). I will attempt to explain what each one is and how they are related.

1) **The Institute of Hazardous Materials Management (IHMM)** is the founding organization and is a non-profit, private group composed of:

- Board of Directors which oversee the Board of Examiners
- Board of Advisors
- Recertification Board
- Research and Publications function.

The Board evaluates the qualifications of candidates, the board monitors and maintains the quality of the exam, administers the exam, grants the CHMM credential, evaluates recertification applications, and grants recertification. IHMM does not conduct membership activities. You must pay your certification fee (\$70 in 2007) each year to maintain your CHMM certification. Payment of the certification maintenance fee does not provide membership into either the National ACHMM or the local chapter. In addition, every five years, during recertification, an additional fee is required (\$75 in 2007).

2) **The National Academy of Certified Materials Managers (ACHMM)** is a separate entity from the IHMM's, however, an affiliation agreement joins the Institute and the Academy. The mission of the Academy is to promote the environmental, health and safety profession, offer professional development and networking opportunities, and to provide value to our membership. As the membership arm of the CHMM program, the role of the Academy is to charter chapters, conduct education and training, provide a conduit for peer interaction and information exchange, and to help define standards in hazardous materials management. The National Academy holds an annual national convention and an annual national leadership training conference. Membership in the Academy is required to vote for National Academy candidates. You pay dues each year (\$85 in 2007) to be a member of the National Academy. Membership in National is not a requirement to maintain your certification. Membership in National does not include membership in the local chapter.

3) **The Eastern Washington Chapter of the Academy of Certified Hazardous Materials Managers (EWC/ACHMM)** has been formed to provide association activities for CHMM Members and Associates in the Tri-Cities area of Eastern Washington. The Chapter is dedicated to the development of professionals involved with

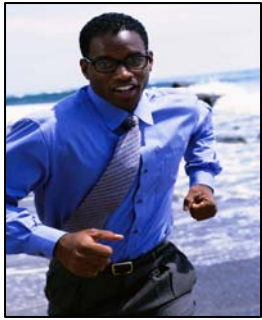
Fellow of the Institute Awarded to EWC Member

The Institute of Hazardous Materials Managers (IHMM) has selected Rampur Viswanath from the EWC as 2007 "Fellow of the Institute." This honor recognizes individuals that have provided outstanding contributions to the field of hazardous materials management and the profession. Fellows nominees must have been certified for at least six years and be nominated by at least two current Fellows; they must also have made significant contributions such as: developing or advancing a new technology, apparatus, or device; implementing a new hazardous materials management principle, methodology, procedure, or technique; advancing the value, importance, and recognition of the profession in the marketplace or the media; training or developing training materials that improve workforce knowledge and skills; performing an honorable or heroic deed; or other acts deemed worthy of such recognition.

Rampur was selected because of his extensive involvement in regulatory compliance and hazard mitigation, as well as his other many notable contributions. His name will be added to the "Fellows of the Institute" listing and an article will be prepared for an upcoming IHMM Bulletin. The IHMM provided Rampur with a Fellows certificate and a Fellows lapel pin in recognition of this honor.

CHMMunity® – Doing More in the Community!

In 2002, the Academy of Certified Hazardous Materials Managers - Northstar Chapter launched an initiative to help assess unpermitted solid waste facilities within the state's beautiful Voyageurs National Park in northern Minnesota. As a result, the chapter provided the National Park Service (NPS) with several environmentally sound recommendations, and so started the CHMMunity® Outreach program.



Because of the chapter's volunteer efforts, NPS received support for a program for which it had no funding.

- CHMMunity® provides a framework for philanthropic projects and community outreach.

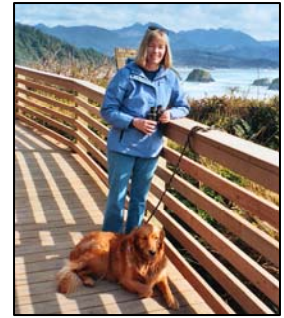
- CHMMunity® gives focus and positive meaning to chapter activities.
- CHMMunity® encourages volunteer participation.

CHMMunity® is a top-notch recruiting tool for new members and can also garner important recognition from the community, local government agencies and media.

When an ACHMM member or chapter finds a potential project, funding may be needed for operations. Funding for the project can come from multiple sources, including: dona-

tions from corporate sponsors, chapter monies, donated services and/or grant support from ACHMM. Grants of up to \$500 are available from ACHMM on a quarterly basis. ACHMM guidelines:

- Not have adequate funding from an internal source
- Be a public, quasi-public or nonprofit organization serving a broad constituency
- Have authority to allow ACHMM participation on the property
- Have a hazardous materials component
- Not require insurance for access
- Have potential to showcase ACHMM and garner media coverage



Additionally, the selected project should provide some guidance and support, ac-

all aspects of hazardous materials management. The mission of the Chapter is to provide a balanced program for Certified Hazardous Materials Managers in the following four areas: 1) Environmental Health and Safety; 2) Regulatory Compliance and Policy; 3) Science and Technology; and 4) Materials Handling, Emergency Response, and Remediation.

Eastern Washington Chapter activities include: Monthly meetings (alternating between board meetings and presentations or tours of general interest); Annual CHMM training programs and administering CHMM exams; Several annual awards sponsored by local companies; Partnering with the local community; and Providing scholarships to encourage students pursuing a career in the hazardous materials area. You pay dues each year (\$25 in 2007) to be a member of the Chapter. Membership in the Chapter is separate from membership in the National Academy. Membership in the Chapter is not a requirement to maintain your certification. Being a CHMM is not a requirement to be a member of our Local Chapter; non-CHMMs are affiliates members.

Please note that EWC/ACHMM is here to serve local members and the local community. We do not receive funding from National; all of our activities happen thanks to our local members (through dues and volunteerism). For our EWC/ACHMM members, attendance at local chapter meetings provides credits for recertification. Also our board meetings are open to all members to come and share their ideas and get involved.

Each of the above organizations is a separate entity. Memberships in the National ACHMM and the Chapter are completely separate. You can be a member of one and not the other.

ACHMM 2007 National Conference

This year's conference will be taking place at the Hyatt Regency Crystal City, just outside Washington, DC.
