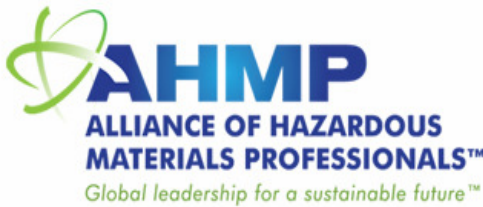

Fine Wine, Gracious Hospitality and Sunshine

The EWC's annual Winery Social was held this year at Cañon de Sol on August 14th. The winery's name is derived from the Spanish language, meaning *Canyon of Sun*. Owner and winemaker, Victor Cruz (and his wife Kim), provided the Chapter with an amazing evening at their winery, which is located in Badger Canyon below picturesque hills.

Although the Cañon de Sol winery is only open to the public once a year during crush, Victor and Kim graciously opened the winery to the EWC for the Winery Social. They were kind enough to describe the history of the winery, from both of their perspectives, which provided some very entertaining stories indeed!

Victor also shared many of his winemaking "secrets" including his oak treatment and duration, fruit sources (among which are the renowned Champoux and Lewis vineyards), and winemaking philosophy (Professor Cox – you missed out!). Victor poured his award-winning Syrah and Merlot in addition to his Viognier, Meritage and a limited-bottling Red Table Wine that is only available by the glass at the finer restaurants in Western Washington – he calls it his "Seattle Wine."

The excellent wine was complimented by wonderful hors' de oeuvres from Castle Catering, and the evening culminated with a trip to the cellar where Victor opened no less than six barrels for tasting! The hospitality provided by Kim and Victor was comfortable and gracious, and a great time was had by all (incriminating evidence is provided in the photos)! The Universal Waste Rule for Lamps

In Washington State the Universal Waste Rule per WAC 173-303-573(5), allows less burdensome management of batteries, lamps, thermostats and mercury-containing equipment. These wastes can be managed as either universal waste (UW) or dangerous waste. UW requirements for storage, transportation and collection are less stringent. In most cases UW management is much easier and preferable alternative to dangerous waste management.

Nationally, about 680 million lamps are disposed of annually, most to solid waste disposal facilities, including landfills and solid waste incinerators. Fluorescent lamps contain a small amount of mercury which is released when the lamp is broken. During waste handling and disposal, many lamps break, releasing mercury vapor and potentially exposing waste handlers to inhalation of those vapors.

The mercury content in newer fluorescent tubes ranges from 3.5 milligrams to 8 milligrams or more. Some older fluorescent tubes (pre-1999) contain up to 50 milligrams of mercury. High Intensity Discharge (HID) lamps (e.g., mercury vapor, metal halide, high pressure sodium) may contain up to 250 milligrams, depending on the lamp wattage.

Some lamps contain lead in the glass and

lead solder in the base. Lead is a toxic metal that may leach from solid waste landfills into the ground water. Manufacturers are eliminating the lead by using non-lead glass and solders in new lamps.

Although fluorescent and HID lamps contain toxic mercury and should be recycled, people are encouraged to continue using them because they use much less electricity and last much longer than other types of lighting. For this reason, fluorescents are a better long-term choice for the environment.

The types of lamps that may be Universal Waste include Fluorescent, Neon¹, HID and any other lamps that are dangerous waste. To dispose of lamps in Kennewick, contact Empirical Company at 735-1848 or Tetra Tech (ex SCM Consultants) at email: michaelb@scm-ae.com.

There are three choices when determining if your spent lamps are a dangerous waste:

(1) Assume your lamps are a dangerous waste; (2) use manufacturer's information, MSDS and other available information to designate by knowledge; OR (3) designate by sampling and testing.
