### **SAFETY AND HEALTH UPDATE FROM CONGRESS**

Although the only action taken by Congress has been to swear themselves in (and to deal with ethics violations and tape recordings), a few developments on the safety and health policy front

have occurred which I thought would be interesting for folks.

#### SENATE

The new chair of the Labor and Human Resources Committee, Jim Jeffords (R-VT), has created a new Subcommittee on Public Health and Safety which will have jurisdiction over all OSHA matters (last year all OSHA matters were handled at the full committee level). The Subcommittee will be chaired by Sen. Bill Frist (R-TN), a relative newcomer to the Senate. Frist's only history on job safety and health policy is his vote in Committee last year for the Kassebaum-Gregg OSHA Reform bill. Prior to coming to the Senate, Frist practiced medicine in Tennessee.

#### HOUSE

The House has passed a new rules package which will require that any non-governmental witnesses testifying before a Congressional Committee or Subcommittee "shall submit a curriculum vitae and a disclosure by source and amount of federal grants and contracts received by them or any organization they represent in the current and preceding two fiscal years to the extent that the information is relevant to the subject matter of the testimony." This rule builds on work from the last Congress to restrain federal grant monies to non-profit entities. For more information, contact Deborah Lewis at the Alliance for Justice (dlewis@afj.org).

#### NEW LEGISLATION

The first day of the 105th Congress saw the introduction of a number of new bills. None addressed the issue of OSHA reform. There was one bill introduced which may play a role in the regulatory reform debate, this bill (H.R. 96) will provide additional assistance to small business in complying with regulations. A more detailed analysis of this bill will be prepared if it begins to move.

#### SBREFA

You might recall that the 104th Congress passed this law which will have a major impact on the development of OSHA regulations and OSHA enforcement. All year, these updates will examine the implementation of this very dangerous piece of legislation.

Senator Kit Bond (R-MO), Chair of the Senate Small Business Committee and one of the principal authors of SBREFA, plans a full schedule in the coming year to "make sure federal agencies comply with the provisions of the law. Bond plans to hold a number of oversight hearings, including a series of field hearings.

OSHA's tuberculosis rule has been subject to review by a SBREFA panel. The panel has made numerous recommendations on ways to alter the proposed rule, purportedly in the interests of small business. The proposed changes would require exempting additional industries and requiring that OSHA conduct a number of cost-benefit analyses which will delay the issuance of the proposal.

OSHA's recently published final rule on methylene chloride may be the first regulation subject to the Congressional review provisions of SBREFA. The Halogenated Solvents Industry Association is pressing legislators to review the rule and to reject it once it comes to the Congress for approval.

**EWC-ACHMM SCHOLARSHIPS**

We have Good News ! The EWC-ACHMM is sponsoring two scholarships for college students interested in enrolling in hazardous materials management courses. The last date for filing the application forms, provided by EWC-ACHMM, is April 1, 1997.

A scholarship to encourage high school graduates in Eastern Washington to pursue a career related to Hazardous Materials Management is offered. Graduating seniors who will be freshmen in college in the upcoming semesters in 1997 will be eligible to apply. The successful applicant will be awarded a sum of \$ 200.

Another scholarship to encourage ex-employees of the Hanford Site to pursue college courses or a review course in Hazardous Material Management is also available. The student must be enrolled in a course on Hazardous Material Management, Environmental Science or Engineering leading to a degree or a certification. The successful candidate will be awarded a sum of \$ 300.

### **CHMM RECOGNIZED BY THE NATIONAL ENVIRONMENTAL TRAINING ASSOCIATION**

The following is an article from the NETA news, Winter 1996-97 (NETA is the National Environmental Training Association). I thought it would be of interest.

The NETA Board of Directors on November 8, 1996 formally recognized the Certified Hazardous Materials Manager (CHMM) credential, offered by the Institute of Hazardous Materials Management, Rockville, MD, as satisfying the technical qualifications --in lieu of NETA's technical test--for the CET Management and Transportation of Hazardous Materials and Waste specialty area.

Recognition of the CHMM is the sixth independent voluntary certification to meet NETA's rigorous criteria for recognition of independent certifications in lieu of testing. The others are the Certified Safety Professional (CSP), Certified Industrial Hygienist (CIH), Occupational

Health and Safety Technologist (OHST), Construction Health and Safety Technologist (CHST) and those registered by the National Registry of Radiation Protection Technologists (NRPPT).

Independent certifications are recognized by NETA only when the qualifications and examinations are substantially similar to the CET process. Consideration is given to recognizing other certifications only when a substantial group of individual members (or potential members), or an organization which offers another certification, requests NETA or the Board of Examiners to consider recognition. The BOE then thoroughly investigates the process used by the other certification, including test development and administration, and interviews numerous individuals holding the other certification before making a recommendation to the Board of Directors.

Recognition of the CHMM is expected to open a number of areas of cooperation between NETA and the Academy of Certified Hazardous Materials Managers (ACHMM), the CHMM membership organization.
