Leadership Conference Highlights

The following article was taken from a presentation by one of the speakers at the Leadership Conference. It was an interesting talk since a scene from Donald Trump's television program "The Apprentice" was used as a video aid.

Adriane Borgias has worked for over 25 years in the energy industry and with Indian tribes. She is currently the owner of fusion environment&energy, LLC, an environmental consulting firm with offices in Spokane, Washington and Bend, Oregon. She is experienced in agency collaboration, regulatory review, environmental management systems, auditing and continuous improvement, hazardous materials and waste compliance, pipeline construction and inspection, site assessment, investigation and remediation. Her most recent interests have been in collaborative decision-making and she has worked with American Indian Tribes in the Pacific Northwest, as a participant on the Intertribal Council on Hanford Health Effects, Pacific Northwest Tribal Air Network, and the Kootenai Valley Resource Initiative in establishing the TMDL for the Kootenai River Watershed. Adriane is a former licensed nuclear reactor operator, a contributor to Women in Chemistry and Physics, and has been profiled in Northwest Women in Science.

Adriane has been a CHMM since 1986, and is well known to ACHMM members as co-founder of the Northern California Chapter, and past president of the National ACHMM. She received the ACHMM President's Award for Outstanding Service in 1990, and the Founder's Award in 1996. She is currently technical editor of the ACHMM book, Hazardous Materials Management Desk Reference.

REGULATORY REPORT

EPA ISSUES FINAL RULE REVISING THE UNIFORM HAZARDOUS WASTE MANI- FEST REGULATIONS

On March 4, 2005, EPA published a final rule in the FR revising the Uniform Hazardous Waste Manifest (UHW) regulations and the manifest and continuation sheet forms used to track hazardous waste from the site-of-generation to the site-of-disposition. The final rule revisions include:

- Proposed removal of several fields such as the state manifest tracking number; the state generator ID field; the state transporter's ID fields; the transporter's phone fields; the state facility's ID field; the facility's phone field;
- Proposed consolidation of additional descriptions and special handling fields;
- Continuation sheet;
- Addition of new data elements such as generator site address field; emergency response phone number field; and international shipments field;
- Proposed addition of the third transporter field;
- Reduction or elimination of "optional" field designations;
- Proposed standardization of handling codes; and
- Proposed standardization of RCRA waste code fields.

The revisions will standardize the content and appearance of the manifest form and continuation sheet, make the forms available from a greater number of sources and adopt new procedures for tracking certain types of waste shipments with the manifest. The final rule becomes effective September 6, 2005.
